The eighteenth day of the month of February in the year 2004, at 11:00 pm GMP time,
The Emission Committee of Dhura, dealt in art. 47 of the Regulations for Dhana, issued
on the 12th of June 2002 by the Committee of the Representatives of the Republic of the
Earth,

pointed out that:

1. following art. 47 of the Regulations for Dhana, the Emission Committee proposes to the General Council the emissions of Dhana and carries out or has carried out decisions regarding Dhana;
2. following art. 24 of the Regulations for Dhana, those belonging to the Republic of the Earth are assigned one hundred Dhana in paper notes of different denominations.
3. following art. 25 of the Regulations for Dhana, Dhana is assigned on condition of reimbursement costs, the sum of reimbursement is proportional to the annual average income of the country receiving the assignation;
4. following art. 26 of the Regulations for Dhana, the consignment of the hundred Dhana assigned to members of the Republic of the Earth will take effect after the reimbursement of the emission cost and before receipt of the sum the beneficiary must indicate three new members of the Republic of the Earth.
5. following art.37 of the Regulations for Dhana, Dhura spreads Dhana on the planet using its own staff ad covering the relative costs;
6. the Regulations for the Diffusion of Dhana, approved and issued by the Committee of the Representatives of the Republic of the Earth on the 14th of June 2002, states:
 - (art.2) that who becomes part of the Republic of the Earth is assigned one hundred Dhana, Dhana in tickets is assigned by reimbursing its emission cost, the amount of the reimbursement of the emission cost is proportional to the average yield for inhabitant of the different countries as indicated in the schedule attached to the regulations of Dhana, the one hundred Dhana assigned are delivered after the payment of the reimbursement of the printing costs and the subscription of at least three new participants to the Republic of the Earth;
 - (art. 3), who asks to become part of the Republic of the Earth: a) underwrites the application form of the Republic of the Earth; b) pays the amount of the emission cost of one hundred Dhana in his own national currency; c) finds three new subjects that ask to become part of the Republic of the Earth; d) is assigned one hundred Dhana; e) receives in his own national currency a price twice the paid amount;
7. objections concerning the diffusion of Dhana have raised in the Italian Republic, where it has been considered an investment solicitation means, due to the fact that the assignment of one hundred Dhana in material money requests the reimbursement of its emission cost;
8. such objections, leaving a part their legitimacy and/or truth, can represent an unforeseen difficulty in the Dhana diffusion process in the Italian Republic;
9. Dhura's General Council (art. 47 of the Regulations for Dhana), which is assigned by the art.39 of the same Regulations for Dhana all the powers concerning emission, management and control of Dhana and its monetary system, has asked the Committee of Control to remove the aforesaid difficulties;
10. in relation to the General Council's request, the Committee of Emission has urged the Dhana Diffusion Coordinators of all the countries to point out the possible solutions;
11. the Dhana Diffusion Coordinators have reminded that such objections haven't raised in any other Country;

12. the same Diffusion Coordinators have exhorted not to modify the assignment procedures which have to be adopted in the same identical way in each country;

13. the Coordinators of some Countries have also called the attention on the fact that although in other Countries part of the Dhana assigned is addressed to finance the public debts of the relative states, in their Countries this allocation doesn't appear to be necessary;

14. the aforesaid Coordinators have communicated that a great part of adherents of their Countries have declared themselves ready to put part of the Dhana they've received in assignment at Dhura's disposal, in order to continue Dhana's diffusion in the Italian Republic without asking any reimbursement of the emission cost until objections are overcome;

establishes that:

the assignment of Dhana in the Italian Republic will be carried out without any reimbursement request, this by using the Dhana that have been put at this purpose's disposal by adherents of other Countries, précising that, other conditions provided by letters a), c), and d) of art.3 of the Regulations for the Diffusion of Dhana (subscription of the act of adhesion to the Republic of the Earth; finding three new subjects that are willing to become part of the Republic of the Earth; receiving the one hundred Dhana assigned) remain valid.
