

Legal tender currency must be replaced with the work currency

What's currency for? Legal tender currency is the means to concentrate wealth, exploit work and give rise to the poverty of the majority of human beings. This currency is just a blank false bill with no maturity date. It has absolutely no real value. It works just because it's imposed by law and is accepted as payment. If it was worth something, it wouldn't need any legal tender. Less than three per cent the legal tender currency is used in trade exchanges, all the rest is addressed to financial operations.

Dollar, euro, pound, yen and all the other currencies emitted by the central banks have the only purpose of making the states go in debts and to be the advantage of a narrow elite that uses banks to control economy, finance, culture, science and information. This way a few organized people govern the world, cause wars, steal resources and affect the development of the whole humanity. These elites are responsible for all national governments and their international institutions, states' bureaucracies and multinational organizations.

How can this situation be changed? Originally, currency was born to represent goods. Now, legal tender currency represents only the work necessary to produce goods payable with this currency. It's not worth anything anymore. It's accepted as payment just owing to ignorance. It's a great fraud that only takes place because those accepting legal tender currency don't know it's not worth anything, beginning to who emits it until those who control it. The only way to redistribute wealth, give work the right value and win poverty is the adoption of a currency with real value representing work, issued on behalf of the workers. Dhana (www.dhana.org) has been issued for this purpose.

How to spread the work currency? The only effective way to spread Dhana is the workers ask for it as payment. This way, enterprises will be forced to get hold of the currency in order to pay wages and salaries. But since Dhana can only be assigned to each person (100 Dhana each), enterprises will have to sell their goods and services in Dhana to obtain the necessary amount to pay the workers. It's simple. It just takes to understand it. And do it!

Dhana is issued by Dhura (www.dhura.org), a body established by the Republic of the Earth (www.asmad.org), the world government elected directly by the inhabitants of the planet. Each Dhana is guaranteed by a real value equal to one gram of platinum. Dhana is issued in physical, electronic and telematic currency. Dhana is divided in one thousand Kana-Dhana and is issued in 1, 5, 10, 50, 100 Dhana and in 1, 5, 10, 25, 50, 100, 250 Kana-Dhana denominations. Each inhabitant of the planet aged at least sixteen years old is assigned 100 Dhana against the reimbursement of the issuing cost, different for each country proportionally to the average per-capita yield, or against the commitment to perform 100 hours of work (one hour each Dhana) in one or more times within five years from the date of assignation.

The amount of Dhana to be issued won't exceed 500 billions Dhana (100 per 5 billions people aged at least 16) except another 25 billion Dhana (5 per cent) to be addressed exclusively to humanitarian initiatives. The 1000 Dhana denomination has been issued for this purpose. The issue limit prevents the devaluation of the currency that this way will keep revaluating during time, because by increasing exchanges and therefore the demand for Dhana without increasing the quantity of Dhana issued, the value of Dhana can only increase. Also this is easy to understand.
