## Abbottabad, silver, and time zones

Most silver is used by the industry of the weapons. The price of silver had gained nearly 500% over the past two years. In the first four months of 2011 was increased by 45%.

It is estimated that the value of the futures (forward delivery commitments) on silver is at least 30 times the underlying physical silver, ie for each ounce of silver available for delivery commitments are at least 30 oz.

Friday, April 29, 2011, at the Chicago Merchantile Exchange (CME), many holders of silver *futures* have asked for physical delivery.

If the delivery had been made, the coffers of those who issued the *futures* would remain empty and the holders of *futures* would expire after completely uncovered.

What to do? Solution. Suddenly, the CME has increased ("to combat the volatility in the markets"), the percentage of deposits required to investors to buy silver futures contracts from 6% to 11% of the value of the contract and the amount of minimum deposit from 14,513 dollars to 25,397 dollars, an increase of 75%. Never happened.

This move has caused an immediate reduction in the price of silver and has convinced investors to monetize *futures* expiring instead of insisting on physical delivery of silver. After the closing of the CME, the exchange has continued over the counter.

But the effect of CME's move would be temporary. From Monday, May 2, 2011 the request for surrender would continue, with the risk that the fraud was uncovered on silver futures (and perhaps even gold, for which the relationship between *futures* and metal is even higher).

To get to monetize on silver *futures*, rather than the delivery of the metal, it was necessary to strongly reduce the price of silver. How? Waiting to find other technical solutions, the only remedy was to reduce demand and thereby reduce the production of weapons, or at least give this impression.

And here is the move to Abbottabad, an operation prepared for a long time.

On the afternoon of Friday, April 29, 2011, the blitz is decided.

Let's look at the time, considering the time zones.

About an hour before midnight on Sunday 1 May 2011, in the area of Abbottabad lights are turned off by order of the Pakistani military.

American helicopters arrive to Abbottabad shortly before midnight Sunday, May 1, 2011, when in Washington are 2:00 p.m.

The operation takes less than an hour. President Obama shall be informed immediately, "Geronimo EKIA (Enemy Killed In Action)".

Monday, May 2, 2011, at 1:30 a.m. (time in Pakistan), U.S. helicopters have already left Pakistan and are safe. In Washington are 3:30 p.m.

President Obama's announcement at 11:35 p.m., eight hours later.

For eight hours, the President has kept quiet about the news. Why?

Then, at 10:00 p.m. of Washington (9:00 p.m., in Chicago), something happens.

And the President decided to speak.

We found out the reason and it would be appropriate for President Obama to explain it. It would be the lesser evil.
